## Climbing and bouldering facility

### Rules of use

#### 1. General information

This climbing and bouldering equipment is designed for climbing in accordance with DIN EN 12 572 and is not playground equipment in accordance with DIN EN 1176.

#### 2. Safety

Bouldering, climbing and the intended use of the facility are always subject to risks. Bouldering and climbing as risky sports are associated with dangers and therefore require a high degree of caution and personal responsibility. All users recognize the resulting duty of care and only use the facility in a condition that enables them to do so.

2.1 All users use the facility at their own risk (parents are liable for their children) and are aware that handles and steps in particular can turn, break and fall off at any time. Any defects found (e.g. loosened handles) must be reported immediately.

2.2 Modifications to the equipment, the handholds and the floor are strictly prohibited.

2.3 Staying in the fall area below climbers - except for spotting - is to be avoided, except when spotting. Objects are to be deposited outside the fall area in the equipment compartments.

2.4 During bouldering and climbing courses, free training may be restricted. Mutual consideration is imperative.

2.5 Over-climbing and standing on the facility is prohibited.

2.6 Other forms of use than sport climbing, in particular drytooling (ice climbing), are prohibited.

2.7 The outdoor facilities may not be used during thunderstorms or lightning. Each user is responsible for taking precautions in this regard.

2.8 Recognized belaying methods must be used.

2.9 When climbing, the carrying of non-essential sporting objects (e.g. smartphones) with the risk of falling is prohibited.

#### 3. Liability

3.1 The TUM accepts no liability for personal injury or damage to property.

3.2 Anyone who causes damage to property or injures persons must bear the consequences themselves and is liable for the damage they cause

#### 4. Authority to give instructions and non-compliance with instructions

The instructions of the persons authorized to give instructions must be followed. In the interest of smooth operation and maintenance of the facility, compliance with these instructions is essential. In all other respects, the ZHS regulations for use shall apply. In the event of non-compliance, the climbing or bouldering authorization may be withdrawn.
